My signature below attests to my intent to hold harmless and release from all liability to Blue Mountain Humane Association and its agents from all acts which are related to normal risk associated with the fostering of an animal including illness this animal may incur or currently have.

I understand that BMHA will take very precaution to ensure that the animal(s) I foster are in good health or that any known problems are discussed with me. However, BMHA cannot be held liable for any unforeseen health problems that may occur once the animal is in my care. I understand the risk of these known and unknown health issues being transmitted to my own pets and BMHA is not responsible for any medical treatment for my own pets as a result of such illness.

I agree to provide food, water, shelter, and care as directed by BMHA.

I agree to take animals to BMHA or a veterinarian for medical treatment, vaccinations, spay/neuter surgery, and any other required medical care as instructed by BMHA.

I understand that all medical treatment for foster animals must be pre-authorized and arranged for by BMHA. BMHA is not responsible for the cost of any unauthorized medical treatment.

I understand that foster animals are temporarily in my care and belong exclusively to BMHA.

Blue Mountain Humane Association reserves the right to deny any application that is deemed unsuitable for the animal.

**Release and Waiver of all Claims**

You fully realize that you will be participating in a fostering capacity at the Blue Mountain Humane Association, an animal shelter, and doing so of your own free will and initiative and at your own risk and responsibility. You understand that animals may be unpredictable and assume the risk of being scratched, bitten, or injured or frightened by cats or dogs in connection with this volunteer capacity with BMHA. You acknowledge that you understand and accept the inherent risks associated in this capacity.

To the fullest extent permitted by law, you hereby release, waive, discharge, and hold harmless Blue Mountain Humane Association, its officers, directors, employees, agents, and affiliates from any and all

claims, demands, causes of action, liabilities, and expenses, including legal fees, arising out of or in any way connected to your volunteer activities.
